**BUDGET HEARING AND ANNUAL MEETING**  
**AND ELECTION NORTH GREENBUSH COMMON SCHOOL DISTRICT**

NOTICE IS HEREBY GIVEN that the Board of Education of the North Greenbush Common School District will hold a Budget Hearing at the North Greenbush Common School District Office, 48 North Greenbush Road, Unit B, Troy, New York 12180 on Wednesday, May 8, 2019 at 6:15pm, prevailing time, for the purpose of discussion of the expenditure of funds and the budgeting thereof proposed by the Board of Education for the school year July 1, 2019 – June 30, 2020.

NOTICE IS GIVEN that a copy of the statement of the amount of money which may be required for the following year for school purposes, exclusive public money, may be obtained by any resident in the District at the District Office, 48 North Greenbush Road, Unit B, Troy, New York 12180 during the 14 days immediately preceding the annual budget vote and election, between the hours of 9:00am and 3:00pm prevailing time, other than Saturday, Sunday, or a holiday, together with the text of any resolution to be presented to the voters. A copy of the detailed statement of estimated expenditures will also be made available at the BUDGET HEARING to be held May 8, 2019.

NOTICE IS GIVEN that the Annual Vote upon appropriation of the necessary funds to meet the estimated expenditures for school purposes for the 2019-2020 school year and the election of members of the Board of Education and any other business that may legally come before this meeting will take place on May 21, 2019, between the hours of 2:30pm and 8:30pm, prevailing time, at the Little Red School House, 49 North Greenbush Road, Troy, New York, 12180.

NOTICE IS GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the Clerk of the District at 48 North Greenbush Road, Unit B, Troy, NY 12180 between the hours of 9:00am and 3:00pm, prevailing time, and no later than Thursday, April 18, 2019, 9:00am to 3:00pm.

The following vacancy is to be filled by the Board of Education:

**Three year term (2019-2022)**  
**Last incumbent: Matthew Jaworski**

Candidates for office of member of the Board of Education shall be nominated by petition and each petition must be filed with the Clerk of the District, and shall be signed by at least twenty-five (25) qualified voters of the District. The petition shall state the residence of each signer and shall state the name and residence of the candidate. Petitions are available beginning March 1, 2019 in the District Office.

NOTICE IS GIVEN that Applications for Absentee Ballots may be applied for at the District Office beginning April 5, 2019. The completed Application must be received by the District Clerk no later than May 14, 2019 at 3:00pm, prevailing time. Absentee Ballots must be received in the District Office no later than 2:00pm, prevailing time, on May 21, 2019.

Qualified voters, who meet the criteria for “permanently disabled” and are so certified by Rensselaer County Board of Elections, will receive paper ballots by mail. A list of all persons to whom Absentee Ballots shall have been issued will be available for inspection in the office of the District Clerk on each of the five (5) days prior to the date of the Annual Meeting and Election between the hours of 9:00am and 3:00pm, prevailing time, weekdays, and such list will also be posted at the polling place at the Annual Meeting and Election of the members of the Board of Education.
